31. When cancelling your membership, we require 30-days notice. If your billing cycle falls inside this 30-days notice period, your next charge will be the last one and you can continue using our products until the end of the next payment cycle. 60. If the dispute is not resolved by agreement within five (5) business days of the Second Party receiving the notice referred to above, either party may refer the matter to mediation conducted by a mediator agreed between the parties within a further five (5) business days or failing agreement within that period, as appointed by the executive director for the time being of the Australian Commercial Disputes Centre Limited.
61. Once a mediator is appointed, the parties agree that:
 - a. The costs of the mediator shall be borne equally between the disputing parties.

- b. The chosen mediator shall determine the procedures for mediation.
 - c. The chosen mediator will not have the power or authority to make any other determination in relation to the dispute.
62. If the parties have not mediated a resolution of the dispute within ten (10) business days of the selection of a mediator, neither party shall be obliged to continue any attempt at mediation under this clause, and either party may then commence such legal proceedings as it considers fit in relation to the dispute.
63. Nothing in this clause prevents a party from commencing proceedings seeking urgent interlocutory relief from a court or tribunal of competent jurisdiction to hear the matter, if, in that party's reasonable opinion, it is necessary to protect their rights.
64. Despite the existence of a dispute the parties must continue to comply with their obligations under the contract.
65. This clause survives termination of these Terms.

Applicable Law

66. These Terms shall be construed in accordance with and governed by the laws of New South Wales. You consent to the exclusive jurisdiction of the courts in New South Wales to determine any matter or dispute which arises between us.

Your Feedback
